Topic: ***An Overview of Credit Risk Modeling***

Coverage: We will start with an outline of the scope of credit risk modeling and briefly describe the various problems that come under this framework. There are broadly two issues involved, namely the determination of the probability of default of individual obligors or instruments and then to derive the loss distribution of a portfolio comprising of such individual instruments. The key challenge is to model default correlations. We will first consider some techniques for determining default probabilities including Merton's model for pricing corporate bonds. Some approaches to determining the portfolio loss distribution such as the KMV, Credit Metrics, Credit Portfolio View, Credit Risk+ and dynamic intensity models will be discussed. Finally we will consider the pricing of credit derivatives such as Credit Default Swaps and CDOs.

Topic: ***Estimation and Testing of Asset Pricing Models***

Coverage: Asset pricing has a rich and well-developed theory. However, empirical studies often fail to exploit theoretical implications which must hold in any coherent model of asset prices. Methods which appear to be very reasonable at first glance often, upon closer inspection, turn out to have deep and fundamental issues, and produce results that mean something quite different than what they are frequently interpreted as meaning. In this workshop, we consider some of the issues that can arise when we try to estimate the parameters of, or test the validity of, asset pricing models, and propose some alternative methods to those commonly used in the finance literature when the extant methods have problems.
